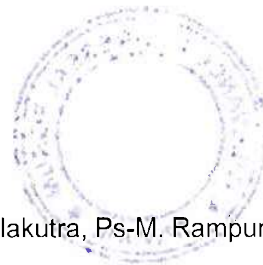

GIST OF THE COMPLAINT:

The complainant consumer Smt. Mukta Dharua, At- Podelkona, Po- Karlakutra, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Madanpur on dt. 20.01.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9034-2404-0556** under SDO Elect. Narla.
- 2) As complained by the complainant that the average bill was served from 05/2012 to 11/2019.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 28/01/2025
- 2) Bill details from: 07/2011 to 12/2024
- 3) Date of supply: 12/03/2011
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – LW505347



- 7) Installed on: 09/12/2019 with IMR "1"
- 8) CMR: 959 Kwh as on 28/01/2025
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR given by AoT Madanpur the old meter was found defective.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the PVR given by AoT Madanpur the old meter was found defective.
- As per billing database the average bill was served from 05/2012 to 11/2019 due to meter defective.

ORDER

31.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 12/2017 to 11/2019 by taking six months average consumption of present meter (i.e. IMR "0" Kwh on 12/2019 and FMR "36" Kwh on 05/2020).
- To withdraw the DPS amount from 06/2021 to 03/2023 as it is a DOMESTIC category consumer.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by February-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
