GIST OF THE COMPLAINT:

The complainant consumer Smt. Maunabati Thapa, At/Po- Madanpur, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Madanpur on dt. 08.10.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.11 KW having consumer no- 9034-2405-0318 under SDO Elect. Narla
- 2) As complained by the complainant that the bill for the month of 03/2024 was served for 2955 units.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect, Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 25/10/2024
- 2) Bill details from: 01/2018 to 09/2024
- 3) Date of supply: 21/01/2018



4) Category: LT/Domestic

5) Connected Load 0.11 KW

6) Meter No - 1663825

7) Installed on: 21/01/2018 with IMR: "0"

8) CMR: N/A

9) The meter status: Defective

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Narla as follows:

- As per the PVR given by the ESO, Madanpur the consumer meter status defective. The consumer has requested to make bill revision from 03/2024 to 08/2024. In the month of 03/2024, the consumer was billed as 2955 KWH and which may be fictitious reading.
- As there is no such meter photo has been uploaded in the system in the month of 03/2024 and onwards, we may revise the bill from 03/2024 to 08/2024 by taking sixmonth average of new meter, so we may install a new meter at the consumer premises.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the PVR given by the ESO, Madanpur the consumer meter status defective. And in the month of 03/2024, the consumer was billed 2955 units, and which may be fictious reading. As there is no such meter photo has been uploaded in the system in the month of 03/2024 and onwards.
- As per billing database the bill was served in 2955 units in the month of 03/2024 and the meter photo has not uploaded in the database.

ORDER 07.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To install a new meter immediately in coordination with MRT.
- ➤ To revise the bill from 03/2024 to 09/2024 by taking six-month average consumption new meter.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will/be treated as non-compliance.
