GIST OF THE COMPLAINT:

The complainant consumer Sri Nilamani Behera, Repr. By Smt Duleswari Behera, At/Po-Madanpur, Ps-Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 17.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.11 KW having consumer no- 9034-2405-0372 under SDO Elect. Narla.
- 2) As complained by the complainant that abnormal excess bill was served in the month of 03/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 28/03/2025
- 2) Bill details from: 01/2018 to 02/2025
- 3) Date of supply: 21-01-2018
- 4) Category: LT/Domestic



- 6) Meter No TWB147989
- 7) Installed on: 21-05-2024 with IMR "0"
- 8) CMR: 295 KWH on 28/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - We may recast the reading from 01/2018 to 03/2024 as IMR "0" KwH and FMR "4697" KwH.
 - Bill may be revise for the month of 5/2024 by taking average of six months of new meter i.e 5/2024 to 10/2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that We may recast the reading from 01/2018 to 03/2024 as IMR "0" KwH and FMR "4697" KwH.
- Bill may be revise for the month of 5/2024 by taking average of six months of new meter i.e. 5/2024 to 10/2024.
- As per billing database the meter was installed from the date of supply bearing meter no. 1665628 in the month of 01/2018 but 3152 unit was billed in the month of 03/2024 of the same meter which seems to be surpress meter reading.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 01/2018 to 03/2024 by taking IMR "0" KwH on 01/2018 and FMR "4697" KwH as on 03/2024.
- To revise the bill for the month of 05/2024 by taking six-month average consumption of new meter installed on 05/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
