GIST OF THE COMPLAINT:

The complainant consumer Sri Arjun Dhangadamajhi, Repr. by Sri Pradeep Dhangadamajhi, At/Po- Madanpur, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Madanpur on dt. 06.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.11 KW having consumer no- 9034-2405-0398 under SDO Elect.

- 2) As complained by the complainant that abnormal bill was served during the period from 01/2018 to 11/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

 - Bill may be revised from 10/2023 to 11/2023 by taking average of six-months of new meter i.e 12/2023 to 05/2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that We may recast the reading from 01/2018 to 09/2023 as IMR 0 kwh and FMR 4071 kwh.
- Bill may be revised from 10/2023 to 11/2023 by taking average of six-months of new meter i.e 12/2023 to 05/2024.
- As per billing database some bill was served high unit consumption meter reading during the period from 01/2018 to 09/2023, which seems supress meter reading.
 Ans average bill was served in the month of 10/2023 & 11/2023.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 01/2018 to 09/2023with IMR "0" KwH on 01/2018 and FMR "4071" KwH on 09/2023.
- To revise the bill for 10/2023 and 11/2023 by taking six-month average consumption of present meter (i.e. IMR "0" KwH on 11/2023 and FMR "180" KwH on 04/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
