GIST OF THE COMPLAINT:

The complainant consumer Sri Benudhar Sahu, Repr. By Smt Kumudini Sahu, AT/PO-Alatara, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 20.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 1 KW having consumer no- **9034-2406-0193** under SDO Elect. Narla.
- 2) As complained by the complainant that the bill was raised without availing power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:
To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 23/12/2024
- 2) Bill details from: 11/2018 to 09/2024
- 3) Date of supply: 14/09/2018
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW



- 6) Meter No – WM419016
- 7) Installed on: NA with IMR: "0"
- 8) CMR: 0 Kwh as on 23/12/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As the consumer has objected that the power supply was not in use since date of power supply to till date and accordingly the AOC/SDO has certified. So, we may withdraw the same i.e billing from date of power supply to till date from the consumer ledger.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as the consumer has objected that the power supply was not in use since date of power supply to till date and accordingly the AOC/SDO has certified.
- As per billing database provisional/average bill was raised from date of power supply (i.e. 14.09.2018) to 09/2024. And the complainant has declared ghost as well as the version of concern SDO has there was no power supply released to the consumer premises against the SC no. 903424060193.

ORDER

06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 09/2018 to 09/2024 as the complainant has not availed the power supply and to stop the account as consumer is not interested to continue the supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by January-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
