## **GIST OF THE COMPLAINT:**

The complainant consumer Sri Birendra Bivar, AT- Borighat, Po- Ailatara, Ps- M. Rampur, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 20.12.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.50 KW having consumer no- 9034-2407-0547 under SDO Elect. Narla.
- 2) As complained by the complainant that the bill was raised without power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

2) Bill details from: 08/2017 to 11/2024


3) Date of supply: 20/06/2017

- 10) Facts of the complainant: Revision of bill
  - 1) As written version submitted by SDO Elect. Narla as follows:
    - The consumer has complained that the power supply was not availed from date of supply to 02/2024, after that the consumer was availed power supply from 02/2024 and as per the PVR given by AOC Madanpur the consumer has not availed the power supply from date of power supply to 02/2024. So, we may withdraw the same period bill from his account.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the consumer has complained that the power supply was not availed from date of supply to 02/2024, after that the consumer was availed power supply from 02/2024 and as per the PVR given by AOC Madanpur the consumer has not availed the power supply from date of power supply to 02/2024.
- As per billing database the provisional/average/actual bill was served from 08/2017 to till date.

## **ORDER** 06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To withdraw the bill from 08/2017 to 02/2024, as the consumer was not availed power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by January-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
