- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the a unit of 1498 was billed in the month of 12/2019 as defective meter reading.
- As per billing database the bill revision has been affect for the the period 08/2022 to 11/2023.

ORDER 22.02.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from 09/2019 to 07/2022 taking average consumption of present meter (i.e. IMR "0" KwH 09/2022 and FMR "301" KwH on 02/2023.

The case is disposed of accordingly.
