The complainant has appeared and submitted during course of hearing at camp court at Karlamunda on dt.20.02.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 1 KW having consumer No 9034-2411-0663 under SDO Elect. Narla.
- 2) As complained by the complainant average billing was served from 10/2018 to 11/2019.
