FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the billing from 08/2018 to 05/2020 was not adjusted in the billing.
- As per billing data base the provisional bill was raised from 10/2018 to 8/2020.

ORDER 22.02.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from 10/2018 to 8/2020 by taking six months average consumption of present meter (i.e. IMR "5315" KwH on 04/2023 and FMR "5823" KwH on 09/2023).

The case is disposed of accordingly.
