GIST OF THE COMPLAINT:

The complainant consumer Sri Nanda Kishore Rana, Repr. By Sri Madhaba Rana, At-Brahmunimunda, Po- Risida, Ps- Karlamunda, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Madanpur on dt. 06.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.05 KW having consumer no- 9034-2412-0756 under SDO Elect.
- 2) As complained by the complainant that excess average bills were served.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:


To revise the excess bill.

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Narla as follows:

We may recast the bill from 04/2019 to 02/2021 by taking IMR 0 kwh and FMR 122 kwh. Bill to be revised from 04/2017 to 03/2019 by taking average of new meter installed i.e from 04/2019 to 02/2021 as IMR 0 kwh and FMR 122 kwh.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that we may recast the bill from 04/2019 to 02/2021 by taking IMR 0 kwh and FMR 122 kwh. Bill to be revised from 04/2017 to 03/2019 by taking average of new meter installed i.e from 04/2019 to 02/2021 as IMR 0 kwh and FMR 122 kwh.
- As per billing database the meter was changed on 17/04/2019 but the average. bill
 was served during the meter running period.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To revise the bill from 04/2017 to 03/2019 as per new meter installed on 04/2019 by taking IMR "0" kwh on 04/2019 and FMR "122" kwh on 02/2021.
- To recast the bill from 04/2019 to 02/2021 by taking IMR "0" kwh on 04/2019 and FMR "122" kwh on 02/2021.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
