#### **GIST OF THE COMPLAINT:**

The complainant consumer Smt. Punyabati Sahu, Repr. by Sri Krushna Chandra Sahu, At- Putigaon, Po- S. Malpada, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Madanpur on dt. 20.01.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9034-2414-0258 SDO Elect. Narla.
- 2) As complained by the complainant abnormal excess bill was served in the month of 01/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

11) As written version submitted by SDO Elect. Narla as follows:

• As per the PVR given by the AoT Madanpur the old meter was found defective.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the PVR given by the AoT Madanpur the old meter was found defective.
- As per billing database some bill was raised in high consumption meter reading, which seems supress meter reading from 10/2018 to 12/2024. And bill revision towards delay meter updating was effect for the period from 12/2019 to 12/2022, effect on dtd. 09.02.2023.

## ORDER 31.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 10/2018 to 12/2024 by taking IMR "0" KwH on 10/2018 and FMR "7793" KwH as on 12/2024.
- > To withdraw the earlier bill revision was effect on dtd. 09.02.2023.
- > To withdraw the DPS amount from 10/2021 to 03/2023 as it is a DOMESTIC category consumer.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>February-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
