## **GIST OF THE COMPLAINT:**

The complainant consumer Sri Gajapati Sahu At- S. Malpada, PO- Sargun, Ps- Karlamunda Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Karlamunda on dt.20.02.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 1 KW having consumer No. 9034-2414-0335 under SDO Elect. Narla.
- 2) As complained by the complainant excess bill raised during 06/2022 to 09/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill raised during 06/2022 to 09/2022.

# SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR dtd. 02.03.2024.
- 2) Billing Abstract from July 2011 to January 2024
- 3) Date of supply 26.08.2010
- 4) Category: LT/ Dom
- 5) Connected Load: 1 KW



- 7) Installed on 19.09.2021 with IMR: "0"
- 8) CMR: 818 as on 02.03.2024 KwH
- 9) Fact of the complainant: Revision of bill
- 10) As written version submitted by SDO Elect. Narla as follows:
  - The consumer was billed abnormal from 06/2022 to 09/2022.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing was raised during 06/2022 to 09/2022. The OP submitted that the consumer was billed abnormal from 06/2022 to 09/2022.
- · As per billing database the bill revision towards delay meter updating for the period 09/2021 to 04/2023 has already been considered effect on 17.06.2023.
- As per billing database amount of Rs. 6742.84 was wrongly debited towards defective period assessment from 01/2021 to 08/202, effect on dt. 12.02.2023, basing on the average consumption from 09/2021 to 03/2022. The reading available in database on 03/2022 is false and was a table reading. As the old meter was already replaced on 09/2021.

ORDER 18.04.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To withdraw the wrong defective period assessment effect on dt. 12.02.2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
