## **GIST OF THE COMPLAINT:**

The complainant consumer Sri Sumani Sahu Repr. by Parameswar Sahu At- S. Malpada, PO- S Malpada, Ps- Karlamunda Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Karlamunda on dt.20.02.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 1 KW having consumer No - 9034-2414-0560 under SDO Elect, Narla.
- 2) As complained by the complainant the average bill was served from 07/2022 to 06/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the average bill.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

• The complainant reiterated for revise the average bill. The opposite party submitted that the consumer was billed as defective from 07/2022 to 06/2023.

## ORDER 22.04.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 07/2022 to 06/2023 by taking average of present new meter (i.e.IMR "0" KwH on 07/2023 and FMR "83" KwH on 12/2023).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
