#### GIST OF THE COMPLAINT:

The complainant consumer Sri Bhupindra Sahu, At/Po- Karlamunda, Ps- Karlamunda, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Madanpur on dt. 19.06.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1.5 KW having consumer no- 9034-2416-0615 under SDO Elect. Narla.
- 2) As complained by the complainant that the power supply is utilizing for domestic purpose but the bill has served as LT/GP.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

# SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 11) As written version submitted by SDO Elect. Narla as follows:
  - As per the PVR given by the AOC Madanpur the consumer is using power supply from 03/2018, but in the GRF it is billing as LT/ GP. So, I request to the Hon'ble GRF for revision of the tariff from 03/2018 to till date under domestic category.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the PVR given by the AOC Madanpur the consumer is using power supply from 03/2018, but in the GRF it is billing as LT/ GP.
- As per billing database the bill was served in LT/GP category from the date of supply.

## ORDER 02.07.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- ➤ To revise the bill from LT/GP category to LT/Domestic from 03/2018 to 06/2025, as the consumer is availing power supply for domestic purpose.
- To serve the bill on LT/Domestic category from 07/2025 onwards.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>July-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
