GIST OF THE COMPLAINT:

The complainant consumer Sri Hemraj Sahu, AT- Banjipadar, Po- Sapalahara, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 20.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 1 KW having consumer no- **9034-2420-0030** under SDO Elect. Narla.
- 2) As complained by the complainant that bill was raised in high consumption during the period 03/2019 to 08/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 04/2002 to 11/2024
- 3) Date of supply: 15/04/2002
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – TPWODL1059263
- 7) Installed on: 01/12/2022 with IMR: "0"
- 8) CMR: 1809 Kwh as on 23/12/2024

10) Facts of the complainant: Revision of bill

1) As written version submitted by SDO Elect. Narla as follows:

- As the consumer has billed suppressed units in the month of 07/2021.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as the consumer has billed suppressed units in the month of 07/2021.
- As per billing database the bill was raised in high consumption meter reading during the period 03/2019 to 08/2022, which seems suppress meter reading.

ORDER

06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 03/2019 to 08/2022 with IMR "0" Kwh on 03/2019 and FMR "9600" Kwh on 08/2022.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by January-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
