#### GIST OF THE COMPLAINT:

The complainant consumer Sri Kambupani Sahu, Repr. By Sri Digar Sahu, At-Sishakhal, Po-Jordobra, Ps-M.Rampur, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 19.09.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9034-2421-0142 under SDO Elect. Narla.
- 2) As complained by the the complainant before the provisional bills has served though the meter was running so the bill may be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 03/10/2024
- 2) Bill details from May 2015 to September 2024
- 3) Date of supply 30/04/2015
- 4) Category: LT/Domestic



- 5) Connected Load 1 KW
- 6) Meter No TW02050464
- 7) Installed on 07/08/2023 with IMR: "0"
- 8) CMR: 405 KwH as on 03/10/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
  - As per the PVR given by the ESO Madanpur the defective period bill to be revised by taking average of six months of new meter.
  - As the old meter was found defective, we may recast the old meter from 07/2020 to 01/2023 taking IMR 3118 KWH and FMR 4475 KWH.
  - The defective period bill from 02/2023 to 09/2023 may be revised by taking average of six months of new meter.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that as per the PVR given by the ESO Madanpur the defective period bill to be revised.
- As Per billing database some bill was raised in high consumption from 07/2020 to 01/2023. And the meter was defective from 02/2023 to 09/2023.

## ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 07/2020 to 01/2023 taking IMR "3118" KWH on 07/2020 and FMR "4475" KWH on 01/2023.
- To revise the bill from 02/2023 to 06/2023 taking six-month average consumption of present meter (I.e IMR "0" KWH on 08/20323 and FMR "137" KWH on 01/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
