GIST OF THE COMPLAINT:

The complainant consumer Sri Miniketan Sahu, At/Po- Muding, Ps- M. Rampur, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Madanpur on dt. 08.10.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no-9034-2423-0024 under SDO Elect. Narla.
- 2) As complained by the complainant that the bill was raised during the line disconnection period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

1) PVR: 29/10/2024

2) Bill details from: 10/2018 to 09/2024

3) Date of supply: 16/09/2018

4) Category: LT/Domestic



- 5) Connected Load 1 KW
- 6) Meter No TWSP51054509
- 7) Installed on: 27/10/2023 with IMR: "0"
- 8) CMR: 60 KwH as on 29/10/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR given by the ESO, Madanpur the consumer meter status is OK.
 The consumer has requested to withdraw due electricity bill from 09/2018 to
 09/2023 as there was no power supply was during that period. But the ESO,
 Madanpur has not certified that period as no power supply.
 - As there is no such data available, we may revise the defective bill from 10/2021 to 09/2023 by taking average reading of new meter from 10/2023 to 03/2024 as IMR "0" kwh and FMR "30" kwh.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the PVR given by the ESO, Madanpur the consumer meter status is OK. The consumer has requested to withdraw due electricity bill from 09/2018 to 09/2023 as there was no power supply was during that period. But the ESO, Madanpur has not certified that period as no power supply.
- As there is no such data available regarding no power supply, so the bill may revise as per regulation 155 of OERC.

ORDER 07.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 10/2021 to 09/2023 by taking six-month average consumption of present meter (i.e. IMR "0" KwH on 10/2023 and FMR "34" KwH on 04/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
