The complainant has prayed for:


To revise the excess bill.

- The complainant reiterated for excess billing. The OP stated that the provisional bill was served to consumer from 09/2020 to 04/2022.
- As per billing database provisional bill was served to the complainant from 10/2020 to 08/2023.

ORDER 22.02.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

➤ To revise the bill from 10/2020 to 08/2023 taking six-month average consumption of present meter installed with IMR "0" KwH on 6/2022 and FMR "174" KwH on 11/2023.
