GIST OF THE COMPLAINT:

The complainant consumer Sri Kurukhetra Bema, At-Ram Mandir Pada, Po/Ps- Bhawanipatna, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Bhawanipatna on dt. 07.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/GP supply with CD of 0.50 KW having consumer no- **9035-1401-0369** under SDO Elect. No-I, Bhawanipatna.
- 2) As complained by the complainant that bill to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No-I, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 30/08/2025
- 2) Bill details from: 01/2009 to 07/2025
- 3) Date of supply: 28.08.2008
- 4) Category: LT/GP
- 5) Connected Load: 0.50 KW
- 6) Meter No – TPWODL1030226
- 7) Installed on: 24.06.2022 with IMR "0"
- 8) CMR: 6331 Kwh on 30/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. No-I, Bhawanipatna as follows:
 - PL bills are served from 06/2009 to 12/2012 average bills are served fro 12/2013 to 04/2015 and 11/2021 to 06/2022. However, the respondent requested the forum to take appropriate decision as necessary.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the PL bills are served from 06/2009 to 12/2012 average bills are served from 12/2013 to 04/2015 and 11/2021 to 06/2022
- From 08/2008 to 05/2012 provisional / average suppress bills have been served.
- Meter no. TPWODL1030226 had been installed on dt. 06/2022.

ORDER

30.08.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- The bills served from 06/2012 to 02/2013 are to be revised by taking average of six consecutive billing of meter no-8135936.
- To recast the bill from 08/2008 to 05/2012 with IMR "0" Kwh on 08/2008 and FMR "2712" Kwh on 05/2012.


The case is disposed of accordingly.

Compliance report must be submitted to the Forum by September-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
