GIST OF THE COMPLAINT:

The complainant consumer Smt Subhasini Sahu, Repr. By Sri Raghu Sahu, At-Irrigation Colony Lane No-15, Po/Ps-Bhawanipatna, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at No-I, BPT on dt. 09.09.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 2 KW having consumer no- **9035-1405-0129** under SDO Elect. No-I, Bhawanipatna.
- 2) As complained by the complainant that the bills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No-I, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 19/09/2025
- 2) Bill details from: 09/2003 to 08/2025
- 3) Date of supply: 09.05.2003
- 4) Category: LT/Domestic
- 5) Connected Load: 2 KW
- 6) Meter No – LW576033
- 7) Installed on: 17.08.2020 with IMR "0"
- 8) CMR:16186 KWH on 19/09/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. No-I, Bhawanipatna as follows:

- PL bills are served from 09/2004 to 05/2009 not adjusted fully after issue of AC bills. However, the respondent requested the forum to take appropriate decision as necessary.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the PL bills are served from 09/2004 to 05/2009 not adjusted fully after issue of AC bills.
- Some bill was served abnormally from 05/2023 to 07/2020 due to suppress meter reading.
- Meter no-LW576033 had been installed on dt-17.08.2020.

ORDER
22.09.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 05/2003 to 07/2020 with IMR "0" Kwh and FMR "9990" Kwh.

The case is disposed of accordingly.

The matter is closed herewith. The compliance report to be submitted to the undersigned on or before **Dt- 31.10.2025**.
