# GIST OF THE COMPLAINT:

The complainant consumer Sri Sumanta Tripathy, Repr. by Sri Hiradhar Sahu, At-Irrigation Colony, Ramsagar Complex, Po/Ps- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Bhawanipatna on dt. 06.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/General Purpose supply with CD of 3 KW having consumer no-9035-1406-0293 under SDO Elect. No. I, Bhawanipatna
- 2) As complain by the complainant that the provisional/average bill was served from 11/2022 to 07/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the PL and AVR bill were serve from 11/2022 to 07/2023.
- As per billing database the provisional/average bill was served from 11/2022 to 08/2023. And the bill revision was done on 26.10.2024 with credit sundry of Rs.23571.62 for the provisional/ average period.
