GIST OF THE COMPLAINT:

The complainant consumer Sri Dama Naik, At- Dangriguda, Po- Depur, Ps- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 15.02.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9035-1408-0555 under SDO Elect. No. I Bh.patria.
- 2) As complained by the complainant that bill was raised during the disconnection period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No. I Bh.patna) in its counter reply and course of hearing submitted as follows:

1) PVR: 04/03/2025

2) Bill details from: 11/2012 to 05/2024

3) Date of supply: 01/01/1990

4) Category: LT/Domestic



- 5) Connected Load 1.5 KW
- 6) Meter No 300043359
- 7) Installed on: 10/01/2023 with IMR "0"
- 8) CMR: 5736 KWH on 01/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. No. I Bh.patna as follows:
 - that the premises is used for domestic purpose bearing consumer No.9035-1408-0555 and that contract demand is 1 KW.
 - As per billing statement PL and Avg bills are served from 12/2014 to 07/2022 due to defective meter. During the above period the line was physically disconnected from 12/2017 to 10/2020, as PVR submitted by ESO, College Square.
 - A new meter was replaced on dt.23.09.2022 with IMR "0" KwH.
 - Presently the line is disconnected from dt.29.01.2024 physically due to non-payment of huge arrear outstanding od Rs. 79509.41.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per billing statement PL and Avg bills are served from 12/2014 to 07/2022 due to defective meter. During the above period the line was physically disconnected from 12/2017 to 10/2020, as PVR submitted by ESO, College Square.

ORDER 27.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 12/2017 to 10/2020 excluding fixed charges.
- ➤ The complainant is directed to pay the balance outstanding arrear as per conditions of supply code,2019 regulation 144 of OERC.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
