GIST OF THE COMPLAINT:

The complainant consumer Sri Rajani Meher, At/Po-Paramanandapur, Ps-Bhawanipatna, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at No-I, BPT on dt. 09.09.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9035-1417-0503 under SDO Elect. No-I, Bhawanipatna.
- 2) As complained by the complainant that the abnormal average bills were served...
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No-I, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. No-I, Bhawanipatna as follows:
 - PL and AV bills are served from 06/2019 to 11/2022. However, the respondent requested the forum to take appropriate decision as necessary.



FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the PL and AV bills are served from 06/2019 to 11/2022.
- From 06/2019 to 11/2022 provisional / average bills have been served.
- Meter no. TPWODL1134652 had been installed on dt-11.12.2022.

ORDER 22.09.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

The bills served from 06/2019 to 05/2021 (2 year) are to be revised by taking average of six consecutive billing of new meter.

The case is disposed of accordingly.
