The complainant consumer Sri Ajit Kumar Padhan AT-Suhagpur. P.O-Deypur Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Bhawanipatna on dt.15.12.23, in brief as follows:
