GIST OF THE COMPLAINT:

The complainant consumer Sri Chandramani Mahananda, At/Po-Paramanandapur, Ps-Bhawanipatna, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at No-I, BPT on dt. 09.09.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9035-1417-1493 under SDO Elect. No-I, Bhawanipatna.
- 2) As complained by the complainant that the bills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No-I, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 13/09/2025
- 2) Bill details from: 02/2020 to 08/2025
- 3) Date of supply: 14.01.2020
- 4) Category: LT/Domestic
- 5) Connected Load: 1 KW
- 6) Meter No 2051862
- 7) Installed on: 13.01.2020 with IMR "0"
- 8) CMR: 15209 KWH on 13/09/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. No-I, Bhawanipatna as follows:
 - PL bills are served from 02/2020 to 05/2022 and adjusted after every AC billing.
 However, the respondent requested the forum to take appropriate decision as necessary.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the PL bills are served from 02/2020 to 05/2022 and adjusted after every AC billing.
- Some bill was served abnormally from 01/2020 to 08/2025 due to supress meter reading.

ORDER 22.09.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 01/2020 to 08/2025 with IMR "0" KwH on 01/2020 and FMR "15137" KwH on 08/2025.
- > Any adjustments made during the revision period are also be taken into consideration / DPS charged on the wrong bills are also to be withdrawn.
- ➤ The complainant must clear all dues upon revision of bills.

The matter is closed herewith. The compliance report to be submitted to the undersigned on or before **Dt-31**_A**10.2025**.
