GIST OF THE COMPLAINT:

The complainant consumer Sri Manas Padhi, Repr. by Sri Baikunthabasi Panda, At- Hill town Lane- 2, Po/Ps- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 09.12.2024, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- **9036-1201-0022** under SDO Elect. No. II, Bhawanipatna.
- 2) As complained by the complainant that to withdraw the average bill was raised from 02/2001 to 01/2013 and dismantle the power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 02/2001 to 09/2021
- 3) Date of supply: 31/12/1999
- 4) Category: LT/Domestic
- 5) Connected Load 0.50 KW
- 6) Meter No – WESCO33806
- 7) Installed on: 31/12/1999 with IMR: "0"
- 8) CMR: 1028 Kwh as on 23/12/2024/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. No. II, Bhawanipatna as follows:
 - Abnormal provisional /average bills were served to the consumer from 06/2002 to 01/2013.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Abnormal provisional /average bills were served to the consumer from 06/2002 to 01/2013.
- As per billing database the bill was served average/actual basis from 02/2001 to 01/2013.

ORDER

06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 04/2002 to 01/2013 with IMR "976" Kwh on 04/2002 and FMR "1028" Kwh on 01/2013.
- To serve the final bill along with adjustment of SD amount (if any) & dismantle fees as appropriate as per regulation of OERC.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by January-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
