FINDINGS / OBSERVATIONS OF THE FORUM

• The complainant reiterated for excess billing. The OP stated that the provisional bill was served from 2/2018 to 11/ 2022 due to meter burnt.

ORDER 30.03.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To revise the bill from 01/2022 to 12/2023 by taking six-month average consumption of new meter installed on 30.12.2023.

The case is disposed of accordingly.
