#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Damrudhar Majhi, Repr. by Smt. Sarita Majhi, At-Pardesipada, Po/Ps- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 09.12.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 2 KW having consumer no- 9036-1202-0017under SDO Elect. No. II, Bhawanipatna.
- 2) As complained by the complainant that the bills was raised without power supply during the period from 10/2002 to 06/2019.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. No. II, Bhawanipatna as follows:
  - Abnormal provisional /average bills were served to the consumer from 10/2003 to 06/2019.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Abnormal provisional /average bills were served to the consumer from 10/2003 to 06/2019.
- As per PVR submitted by the ESO, Naktiguda as well as the letter of councillor and nearby consumers of Ward No 11, Bhawanipatna that the complainant was not availed power supply from 04/2007 to 06/2019.
- As per billing database the bill was raised in average basis from 10/2003 to 06/2019.

# ORDER 06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To withdraw the bill from 04/2007 to 06/2019 (excluding fix charges) as the complainant was not availed power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>January-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
