GIST OF THE COMPLAINT:

The complainant consumer Sri Bijaya Kumar Satpathy repr. By Birendra Kumar Kohar, AT- Reo colony quarter no-11. P.O- Bhawanipatna Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Bhawanipatna on dt.25.01.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ ~~DOM~~ supply with CD of 2 KW having consumer no **9036-1202-0109** under SDO Elect. No II, Bhawanipatna.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that the provisional bill was served from 03/2017 to 04/2023. And, A sum of Rs. 65396.00 was credited in the month of 08/2016 as per GRF case no. 363/2015.
- As per billing database the provisional bill adjustment of Rs. 173659.18 has considered in the month of 12/2023.

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- As the provisional bill revision/ adjustment has already been considered in the billing database, so no need to revise the bill.
