GIST OF THE COMPLAINT:

The complainant consumer Sri Dhaneswar Bag Repr. by Sri Jogendra Sahu, At-TV Centerpada, Ps/Po-Bhawanipatna, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent. The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 10.01.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9036-1205-0206 under EE, Elect. Sub-Division No. II, Bhawanipatna.
- 2) As complained by the complainant that the average bills were served though the meter is running.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- · The complainant reiterated for excess billing.
- The OP stated that Dispute bills from 01/2013 to 12/2024 and suppress reading as per PVR may be considered to resolve the case.
- As per billing database the provisional/average bills were served to the consumer for a long period.

ORDER 31.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 01/2013 to 01/2025 by taking IMR "8010" KwH as on 01/2013 and FMR "12880" KwH as on 01/2025.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>February-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
