GIST OF THE COMPLAINT:

The complainant consumer Sri Siddharth Shankar Mund, At- Naktiguda (Old income Tax Colony), Ps/Po- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 10.01.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 2 KW having consumer no- 9036-1206-0965 under EE, Elect. Sub-Division No. II, Bhawanipatna.
- 2) As complained by the complainant that abnormal excess bill was served in the month of 11/2019 and 04/2020.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. Sub-Division No. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

10) Facts of the complainant: Revision of bill

11) As written version submitted by EE, Elect. Sub-Division No. II, Bhawanipatna as follows:

Dispute bills from 08/2023 to 11/2023 may be considered to resolve the case.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

The complainant reiterated for excess billing.

- The OP submitted that dispute bills from 08/2023 to 11/2023 may be considered to resolve the case.
- As per billing catabase some bill was served in high consumption meter reading during the period from 03/2019 to 07/2023, which seems supress meter reading.
 And average bill was served from 08/2023 to 11/2023 due to meter defective.

ORDER 28.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 03/2019 to 07/2023 with IMR "0" KwH on 03/2019 and FMR "18971" KwH on 07/2023.
- ➤ To revise the bill from 08/2023 to 01/2023 by taking six-month average consumption o⁻ present meter (i.e. IMR "0" KwH on 12/2023 and FMR "2677" KwH on 05/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>February-25</u>, by the opposite party after compliance otherwise it will be treated as non-compliance.
