GIST OF THE COMPLAINT:

The complainant consumer Sri Sanjib Durga, Repr. For Late Nanda Kishor Durga, At-Amgachpada, Po/Ps- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 08.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 4 KW having consumer no- **9036-1207-0345** under SDO Elect. No. II, Bhawanipatna.
- 2) As complained by the complainant that the provisional bill was raised from 04/2018 to 11/2023 due to meter defective.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 10/2009 to 11/2024
- 3) Date of supply: 13/09/2009
- 4) Category: LT/Domestic
- 5) Connected Load 4 KW
- 6) Meter No – TWB601122
- 7) Installed on: 26/12/2023 with IMR: “0”
- 8) CMR: 45 Kwh as on 20/12/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. No. II, Bhawanipatna as follows:
 - Abnormal provisional /average bills were served to the consumer from 10/2018 to 11/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that abnormal provisional /average bills were served to the consumer from 10/2018 to 11/2023.
- As per billing database provisional/average bill was served from 02/2018 to 11/2023 due to house lock and meter defective.

ORDER

06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 12/2021 to 11/2023 by taking six-month average consumption of present (i.e. IMR “0” Kwh on 12/2023 and FMR “41” Kwh on 07/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by January-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
