- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9036-1207-0835 under EE, Elect. SDO II Bh.patna.
- 2) As complained by the complainant that I had convinced about my arrear bill amount after discussion with EE, Elect. SDO NO-II, Naktiguda on 06.06.2025.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

To revise the excess bill.


SUBMISSION OF OPPOSITE PARTY IN BRIEF:

 - As per PVR report it is found that the said consumer premises has been availing power supply for the purpose of temple administration of Sri Radhakrushna Temple, Bhawanipatna. On observation it is found that the consumer is availing power supply in higher tariff, whereas billing is done in LT-_Domestic tariff.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- · The complainant reiterated for excess billing.
- The OP submitted that as per PVR report it is found that the said consumer premises has been availing power supply for the purpose of temple administration of Sri Radhakrushna Temple, Bhawanipatna. On observation it is found that the consumer is availing power supply in higher tariff, whereas billing is done in LT-_Domestic tariff.
- Sri Chandra Sekhar Dakua represent for Sri Radha Krishna Temple has applied for revision of arrear bill to the EE, Elect. SDO No-II, Bhawanipatna & after discussion he has submit application towards withdraw the complaint vide CC no BPT-221/2025.

ORDER 26.06.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

The complainant has withdrawn the grievance application so the case is hereby **Dropped**.
