The complainant has appeared and submitted during course of hearing at camp court at Bhawanipatna on dt.25.01.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 1 KW having consumer no. 9036-1209-0469 under SDO Elect. No II, Bhawanipatna.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

To revise the excess bill.

The complainant reiterated for excess billing. The OP stated that A sum of "3629" units was charged in the month of 06/2023.

To revise the bill by the way of recasting from 03/2019 to 12/2023 with IMR "0" KwH on 03/2019 and FMR "6856" KwH on 11/2023, reversing the provisional adjustment already taken place. Las
