Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 07/2021 to 06/2023 by taking six months average consumption of present meter (i.e. IMR "67" KwH on 07/2023 and FMR "1011" KwH on 12/2023.

The case is disposed of accordingly.
