#### **GIST OF THE COMPLAINT:**

The complainant consumer Smt Saudamini Bag, Repr. By Sri Dayanidhi Bag, At-Purunapada, Po/Ps-Bhawanipatna, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 24.07.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 4 KW having consumer no- 9036-1211-0457 under EE Elect. SDO No-II, Bhawanipatna.
- 2) As complained by the complainant abnormal excess bill was served in the month of 05/2025.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE Elect. SDO No-II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 03/2001 to 05/2025
- 3) Date of supply: 01.01.1990
- 4) Category: LT/Domestic
- 5) Connected Load: 4 KW
- 6) Meter No TWB645388
- 7) Installed on: 22.02.2024 with IMR "0"
- 8) CMR: 8095 KwH on 03/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE Elect. SDO No-II, Bhawanipatna as follows:
  - Disputed bills May-2025 is to be considered to resolve the case. However, the respondent requested the forum to take appropriate decision as necessary.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Disputed bills May-2025 is to be considered to resolve the case.
- The abnormal bill was served on 05/2025 towards meter change assessment for the period 06/2022 to 02/2024 which was bill stop period.
- Meter No. TWB645388 had been installed on dt. 22.02.2024 and the CMR is "8095"
   KwH as on dt. 03.08.2025.

# ORDER 30.08.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

The meter change assessment for bill stop period to be withdrawn effect on dt. 27.06.2025.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>September-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
