#### **GIST OF THE COMPLAINT:**

The complainant consumer Smt Niyati Tripathy, Repr. By Sri Baikuntha Panda, At-Hill Town Lane-4, Po/Ps-Bhawanipatna, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 09-12-24 in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 2 KW having consumer no- 9036-1213-0511 under SDO Elect. No. II, Bhawanipatna.
- 2) As complained by the complainant that to withdraw the provisional bill was raised from 01/2021 to 12/2021 and dismantle the power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional bill.

# FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Consumer had not availed power supply from 01/2021 to 12/2021.
- As per billing database the provisional bill was served from 05/2018 to 12/2021. And the bill was stopped from 12/2021 onwards.

# ORDER 06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To withdraw the bill from 01/2021 to 12/2021 as the power supply was disconnected from the complainant premises.
- > To serve the final bill along with adjustment of SD amount (if any) & dismantle fees as appropriate as per regulation of OERC.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by January-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
