GIST OF THE COMPLAINT:

The complainant consumer Smt Sashirekha Das, Repr. By Sri Alok Kumar Das, At- Naktiguda, Po/Ps-Bhawanipatna, Dist.-Kalahandi the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 09.10.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 2KW having consumer no- 9036-1216-0123 under EE, Elect. SDO No-II, Bhawanipatna.
- 2) As complained by the complainant that some abnormal excess bills were served.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. SDO No-II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 18.10.2025
- 2) Bill details from: 03/2001 to 09/2025
- 3) Date of supply: 30.10.1999
- 4) Category: LT/Domestic
- 5) Connected Load: 2 KW
- 6) Meter No – TW02072234
- 7) Installed on: 01.02.2023 with IMR "0"
- 8) CMR: 17033 KWH on 18.10.2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, Elect. SDO No-II, Bhawanipatna as follows:
  - Abnormal average bills are served from 11/2009 to 02/2016 and from 12/2019 to 07/2024. Disputed bills of abnormal period may be considered to resolve the case.

However, the respondent requested the forum to take appropriate decision as necessary.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing
- The OP submitted that Abnormal average bills are served from 11/2009 to 02/2016 and from 12/2019 to 07/2024. Disputed bills of abnormal period may be considered to resolve the case
- Some abnormal bill was served during the period from 03/2001 to 10/2019 due to suppressed meter reading.

#### ORDER

30.10.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 03/2001 to 10/2009 with IMR "0" kWh and FMR "9120" kWh.
- To recast the bill from 04/2016 to 10/2019 with IMR "0" kWh and FMR "13411" kWh.
- To withdraw the earlier bill revision was effect on dt.30.03.2025.
- Any adjustments made during the revision period are also be taken into consideration / DPS charged on the wrong bills are also to be withdrawn.
- The complainant must clear all dues upon revision of bills.

The matter is closed herewith. The compliance report to be submitted to the undersigned on or before Dt- 30.11.2025.
