- 2. The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

ORDER 19.03.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- ➤ To revise the bill from 07/2023 to 10/2023 by taking six month average consumption of present meter installed on 14.12.2023.
- To recast the bill from 10/2020 to 06/2023 with IMR "0" KwH on 10/2020 and FMR "1156" KwH on 06/2023.

The case is disposed of accordingly.
