GIST OF THE COMPLAINT:

The complainant consumer Sri Rafik Alikhan represented by Sultan, AT- Badli, P.O – Kutrukhamar Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has given in writing and submitted during course of hearing at camp court in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of average / provisional billing of his LT/Dom supply with CD of 2 KW having consumer No. 9036-1217-0372 under SDO No-II, Bhawanipatna.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the bill with installing a parallel meter.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. NO II Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 9) Fact of the complainant: To revise the bill
- 10) As per written version submitted by SDO II Bhawanipatna as follows:
 - The average bill was served from December-2013 to June- 2022 due to house lock.
 - On dated 27.02.2023 bill is revised from April 2019 to June 2022 to reset the units for smooth billing.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

 The complainant reiterated for excess billing. The OP submitted that the average bill was served from December 2013 to June 2022 due to house lock.

ORDER 01.02.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To revise the bill from 12/2013 to 06/2022 by taking average consumption of present meter. (i.e. IMR "01" KwH on 04/2019 & FMR "10286" KwH on 01/2024).

> To withdraw the earlier revision on dt. 27.02.2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
