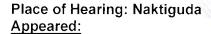

GIST OF THE COMPLAINT:

The complainant consumer Smt Gitanjali Sahu, Repr. By Sri Rajesh Sahu, At/Po-Kuliamal, Ps-Bhawanipatna, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 24.07.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 2 KW having consumer no- 9036-1217-0533 under EE Elect. SDO No-II, Bhawanipatna.
- 2) As complained by the complainant some abnormal bill was served.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE Elect. SDO No-II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

1) PVR: 03/08/2025

2) Bill details from: 06/2013 to 06/2025

3) Date of supply: 13.04.2013

4) Category: LT/Domestic

5) Connected Load: 2 KW

6) Meter No - TWB601239

7) Installed on: 15.12.2023 with IMR "0"

8) CMR: 2971 KWH on 03/08/2025

9) The meter status: Regular

10) Facts of the complainant: Revision of bill

- 11) As written version submitted by EE Elect. SDO No-II, Bhawanipatna as follows:
 - Disputed bills from June-2023 to Aug-2023 is to be considered to resolve the case.
 However, the respondent requested the forum to take appropriate decision as necessary.



FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Disputed bills from June-2023 to Aug-2023 is to be considered to resolve the case.
- From 06/2023 to 11/2023 Provisional/Average bills have been served.
- Some bill was served high unit consumption during the period from 04/2013 to 05/2023 due to supress meter reading.
- Meter No. TWB601239 had been installed on dt. 15.12.2023 and the CMR is "2971" KwH as on dt. 03.08.2025.
- Bill revision adjustment was taken in place for the period 02/2023 to 04/2023 was effect on dt.22.06.2023.

ORDER 30.08.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > The bills served from 06/2023 to 11/2023 are to be revised by taking average of six consecutive billing of meter no-TWB601239.
- The bills to be recasted from 04/2013 to 05/2023 with IMR "0" KwH on 04/2013 and FMR "6700" on 05/2023.
- To withdrawal the earlier bill revision was effect on dt. 22.06.2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by September-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
