GIST OF THE COMPLAINT:

The complainant consumer Sri Ranjit Majhi, Repr. by Sri Amit Majhi, At- Borbhata, Po-Uditnarayanpur, Ps- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 13.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.05 KW having consumer no- **9036-1218-0927** under EE, Elect. Sub Division Office, No. II, Bhawanipatna.
- 2) As complained by the complainant that average bill was served from 02/2015 to 10/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

- To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. Sub Division Office, No. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 29/03/2025
- 2) Bill details from: 05/2013 to 02/2025



- 3) Date of supply: 11.04.2013
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – TWNX508353
- 7) Installed on: 12/11/2023 with IMR "0"
- 8) CMR: 1432 KWH on 29/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, Elect. Sub Division Office, No. II, Bhawanipatna as follows:
 - Disputed bills from 03/2015 to 08/2023 is to be considered to resolve the case.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Disputed bills from 03/2015 to 08/2023 is to be considered to resolve the case.
- As per billing database some bill was served in high consumption meter reading from 04/2013 to 01/2015, which seems suppress meter reading. And average bill was served from 02/2015 to 10/2023.

ORDER

29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 04/2013 to 01/2015 with IMR "0" KwH on 01/2013 and FMR "2323" KwH on 01/2015.
- To revise the bill from 11/2021 to 10/2023 by taking six-month average consumption of present meter (i.e IMR "0" KwH on 11/2023 and FMR "366" KwH on 04/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
