GIST OF THE COMPLAINT:

The complainant consumer Sri Duari Sethi, Repr. by Sri Dhruba Kumar Sethi, At- Sibamandirpada, Po/Ps- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent. The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 13.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 2 KW having consumer no- **9036-1221-0395** under EE, Elect. Sub Division Office, Noi. II, Bhawanipatna.
- 2) As complained by the complainant that excess provisional bills were served.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP.(EE, Elect. Sub Division Office, Noi. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

 - Abnormal provisional bills were served to the consumer from 01/2020 to 12/2023.
 - Disputed bills from 01/2020 to 12/2023 is to be considered to resolve the case.

FINDINGS / OBS to ERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosu/res as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Abnormal provisional bills were served to the consumer from 01/2020 to 12/2023.
- Disputed bills from 01/2020 to 12/2023 is to be considered to resolve the case.
- As per billing database provisional bills were issued which seems to be excess as per actual meter reading recorded in the meter.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 08/2020 to 07/2022 by talking six-month average consumption meter installed on 06/2024 with IMR "0" kwh on 06/2024 and FMR "526" kwh on 11/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
