#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Jogeswar Nag, At- Chancharapada, Po/Ps- Bhawanipatna, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 13.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 2 KW having consumer no- 9036-1221-0576 under EE, Elect. Sub Division Office, Noi. II, Bhawanipatna.
- 2) As complained by the complainant that excess abnormal bill was served in the month of 11/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:


To revise the excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. Sub Division Office, Noi. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

10) Facts of the complainant: Revision of bill

- 11) As written version submitted by EE, Elect. Sub Division Office, Noi. II, Bhawanipatna as follows:
  - Abnormal provisional bills were served to the consumer from 10/2019 to 11/2023.
  - Dispute bills from 10/2019 to 10/2023 is already revised on date 19/02/2025. So abnormal for the month of 11/2023 is to be considered to resolve the case.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- · The complainant reiterated for excess billing.
- The OP stated that Abnormal provisional bills were served to the consumer from 10/2019 to 11/2023.
- Dispute bills from 10/2019 to 10/2023 is already revised on date 19/02/2025. So abnormal for the month of 11/2023 is to be considered to resolve the case.
- As per billing database meter was installed on 09.11.2023and 2272 unit was billed in the month of 11/2023 which seems to be absurd.

# ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill for the month of 11/2023 by taking IMR "184" kwh on 12/2023 and FMR "1202" kwh on 05/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>Aprìl-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
