GIST OF THE COMPLAINT:

The complainant consumer Sri Krishna Jani, Repr. by Sri Jagadish Jani, AT-Budhipadar, Po- Chahagaon, Ps- Karlapada, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Bhawanipatna on dt. 19.07.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9036-1305-0004 under SDO Elect. No. II Bhawanipatna.
- 2) As complained by the complainant that provisional/average bill was raised from 03/2011 to 01/2019 and 12/2023 to 02/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No. II Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from March 2001 to July 2024
- 3) Date of supply 01/01/1990
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No TWSP51143962
- 7) Installed on 22/04/2024 with IMR: "0"
- 8) CMR: 71 KwH as on 13/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. No. II Bhawanipatna as follows:
 - Abnormal average / provisional bills were served to the consumer from 03/2011 to 01/2019 and 12/2023 to 02/2024 due to defective meter.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

• The complainant reiterated for provisional/average billing. The OP submitted that abnormal average / provisional bills were served to the consumer from 03/2011 to 01/2019 and 12/2023 to 02/2024 due to defective meter.

ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 02/2017 to 01/2019 by taking the average consumption on IMR "0" KwH on 02/2019 and FMR "266" KwH on 09/2019.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
