GIST OF THE COMPLAINT:

The complainant consumer Sri Fakir Charan Rout, AT- Dungriguda, Po- Tikrapada, Ps- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Bhawanipatna on dt. 19.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 2 KW having consumer no- 9036-1305-0331 under SDO Elect. No. II Bhawanipatna.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No. II Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from November 2001 to July 2024
- 3) Date of supply 10/09/2001



- 4) Category: LT/Domestic
- 5) Connected Load 2 KW

- 8) CMR: 12 KwH as on 12/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill

As written version submitted by SDO Elect. No. II Bhawanipatna as follows:

• Abnormal average / provisional bills were served to the consumer from January 2008 to January 2011 and July 2014 to July 2022 due to defective meter.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that Abnormal average / provisional bills were served to the consumer from January 2008 to January 2011 and July 2014 to July 2022 due to defective meter.
- As per database the DPS from November 2021 to July 2023 was claimed to the domestic category consumer.

ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To revise the bill from 08/2020 to 07/2022 taking six-month average consumption of new meter install on 03/08/2024.
- > To withdraw the DPS amount claim for the month 11/2021 to 07/2023 as it is a domestic category consumer.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
