GIST OF THE COMPLAINT:

The complainant consumer Sri Romanchal Bhoi, AT- Paria, Po- Chheliamal, Ps-Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Bhawanipatna on dt. 19.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 2 KW having consumer no- 9036-1305-0430 under SDO Elect. No. II Bhawanipatna.
- 2) As complained by the complainant the provisional/average bill was served from 11/2017 to 09/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No. II Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 12/08/2024
- 2) Bill details from May 2011 to June 2024



- 3) Date of supply 07/05/2011
- 4) Category: LT/Domestic
- 5) Connected Load 2 KW
- 6) Meter No LW397863
- 7) Installed on 28/03/2019 with IMR: "0"
- 8) CMR: 2033 KwH as on 12/08//2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. No. II Bhawanipatna as follows:
 - Abnormal average / provisional bills were served to the consumer from 11/2017 to 09/2022 due to house lock.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for average/provisional billing. The OP submitted that abnormal average / provisional bills were served to the consumer from 11/2017 to 09/2022 due to house lock.
- As per billing database the bill has served in provisional basis from 11/2017 to 07/2024 with old meter. A new meter sl no. LW397863 was installed on 28.03.2019, which meter reading is not yet updated in billing database.

ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- ➤ Meter no. LW397863 is to be updated in system and EC bills are to be served as per actual meter reading.
- To revise the bill by way of recasting from 03/2019 to 08/2024 with IMR "0" KwH on 03/19 and FMR "2033" KwH on 08/2024.
- To withdraw the DPS amount from 11/2021 to 07/2023 as it is a domestic category consumer.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
