GIST OF THE COMPLAINT:

The complainant consumer Sri Santosh Deep, At- Dangariguda, Po- Karlapada, Ps-Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 13.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9036-1306-0353 under EE, Elect. Sub Division Office, Noi. II, Bhawanipatna.
- 2) As complained by the complainant that the bill was raised during disconnection period from 2014 to 2017.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. Sub Division Office, Noi. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 28/03/2025
- 2) Bill details from: 07/2006 to 02/2025
- 3) Date of supply: 17/04/2006
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW



7) Installed on: 18/12/2014 with IMR "0"

8) CMR: 51 KWH on 28/03/2025

9) The meter status: OK

10) Facts of the complainant: Revision of bill

- 11) As written version submitted by EE, Elect. Sub Division Office, Noi. II, Bhawanipatna as follows:
 - Abnormal provisional bills were served to the consumer from 09/2011 to 10/2024.
 - Disputed bills from 09/2011 to 10/2024 may be considered to resolve the case. As per PVR report submitted by ESO NO. III, Bhawanipatna and report of the Sarapanch, Karlapada, it is found that the consumer was not availing power supply from 01/2014 to 11/2017, So energy of the said period may be waived.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that abnormal provisional bills were served to the consumer from 09/2011 to 10/2024.
- Disputed bills from 09/2011 to 10/2024 may be considered to resolve the case. As per PVR report submitted by ESO NO. III, Bhawanipatna and report of the Sarapanch, Karlapada, it is found that the consumer was not availing power supply from 01/2014 to 11/2017, So energy of the said period may be waived.
- As per billing database average bill was served from 09/2011 to 11/2021. And abnormal bill was raised in the month of 11/2024.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 01/20 4 to 11/2017 excluding fixed charges.
- To revise the bill from 12/2022 to 11/2024 by taking 6 months average consumption of present meter installed on 18.12.2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by June-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
