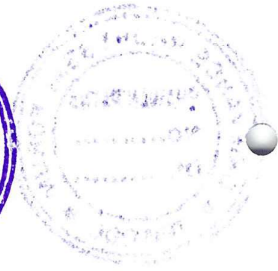

**GIST OF THE COMPLAINT:**

The complainant consumer Sri Bhujan Chandra Bag, At: Haldigaon, Po- Karlapada, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has given in writing and submitted during course of hearing at camp court in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute / meter mismatch of his LT/Dom supply with CD of 1 KW having consumer No. **9036-1306-1107** under SDO No-II, Bhawanipatna.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO No-II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1). Billing Abstract from July-2018 to October-2023

- 3) Date of supply: 24/01/2018
- 4) Category: LT/ Dom
- 5) Connected Load: 1 KW
- 6) Meter No: TWSP51060437
- 7) Installed on: 26.10.2023
- 8) CMR: 45 Kwh on dtd. 28.11.2023
- 9) As per written version submitted by SDO No-II, Bhawanipatna as follows:
  - The provisional/actual bill was served from January-2018 to October-2023 due to meter was not at accessible point.

**FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the provisional/actual bill was served from January-2018 to October-2023 due to meter was not at accessible point.

**ORDER**  
**09.01.2024**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 05/2023 to 10/2023 by taking six-month average consumption of new meter (i.e. 11/2023 to 04/2024).

The case is disposed of accordingly.
