GIST OF THE COMPLAINT:

The complainant consumer Sri Sanatan Sahu, AT- Budhipadar, Po- Chahagaon, Ps- Karlapada, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Bhawanipatna on dt. 23.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9036-1307-0303 under SDO Elect. No. II, Bhawanipatna.
- 2) Abnormal provisional / average bills were served to the consumer from November 2016 to May 2023 due to meter defective.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. No. II, Bhawanipatna as follows:
 - Abnormal provisional / average bills were served to the consumer from November 2016 to May 2023 due to meter defective.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that abnormal provisional / average bills were served to the consumer from November 2016 to May 2023 due to meter defective.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 12/2020 to 11/2022 taking six-month average consumption of new meter install on 01/2023.
- To withdraw the DPS from 11/2021 to 01/2023 as it is domestic category consumer.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
